Stricter rules

- NO WAY to start an extension procedure from Hungary if residence permit expired >> go home, start a new visa case
 - Visa is valid only for 3 months after decision-making (not from the receipt)!
- NO WAY to submit an equity request after residence permit expired
- Other purpose ceased to exist!
- Invitation of family members for graduation: Visa C
- Instead: research / job-seeking
- major limitations are imposed on work purpose
- Family unification with study purpose res.card is only permitted for those who possess a RP issued before January 2024.
- Exception: a baby born in Hungary.

Extension for Studies and Student Mobility Purpose-specific documents



- academic transcript + NEW student status cert. from 27 Aug 7 Sept 2025
- academic transcript + LoExt (Tempus) ≈ mid June // LoAw (Tempus) Dissertation Scholarship ≈ mid June + NEW student status cert. from 27 Aug - 7 Sept 2025 (Tempus also notifies the Immigration Office about the list of students)
- support letter from MATE coordinator (student status cert only later)
- PhD students with NO student status, before final defense:
 - **RESEARCH** purpose possible; accreditation of MATE is accepted
 - o research contract with the university from educational coordinator and supervisor
 - $\circ~$ support letter from your supervisor
- Self-finacing sts: 1st line + verification of transfer
 - Request for reduction of tuition fee (those who exceed the number of semesters; only less than 20 credits) until 15th (?) Sept. 2025 (decision in a month)
 - Request for payment in instalments until 15th Sept. (?) 2025 (kind of automatic)
 - $\circ~$ Only ONE of the above requests can be submitted
 - Verification of transfers can be issued right after the payment happens
 - <u>https://ed.uni-mate.hu/</u> (Study information requests, timetable of the semester; Finance tuition fee payments)



Extension for Job – seeking Purpose-specific documents



- valid only for max. of 9 months
- cannot be converted into study purpose residence card
- can be converted into a work purpose card **but** stricter rules (employment/Hungary card/EU blue card)
- registration by Munkaügyi Központ (authorities for employment);
- **degree** Previous level degree or a degree from home is NOT good!
- 24,000 HUF procedural fee
- colour photo (jpeg format), your blue ink signature underneath > electronically generated application form
- accommodation lease contract + notification of accommodation, (if no change > old address certificate)
- health insurance (private for 6 months + savings)
- financial background (last 3-month bank statements, family members)



Extension for Research Purpose-specific documents

- valid until the date of your contract
- cannot be converted into study purpose residence card
- can be converted into a work purpose card **but** stricter rules (employment/Hungary card/EU blue card)
- MATE is now an accredited
- <u>Necessary documents:</u>
 - ✓ **hosting agreement and the letter of commitment**, signed by the Rector.
 - <u>contract for personal service on research tasks</u>, signed by a representative of the Institute concerned. "University's representative, XY, on behalf of the Rector.
 - ✓ Appendix 9.11
- Solution for Dissertation scholarship holders to finish their studies.
- 26,000 HUF procedural fee
- colour photo (jpeg format), your blue ink signature underneath > electronically generated application form
- accommodation lease contract + notification of accommodation, (if no change > old address certificate)
- health insurance (private for 6 months + savings)
- financial background (last 3-month bank statements, family members)



Extension for Work/Hungary card/ EU blue card Purpose-specific documents

- work agreement / pre-liminary work agreement / assignment contract
- Filipino, Georgian and Armenian citizens
- Hungary card degree earned abroad, related to a given field which is regulated by law
- EU blue card salary 833.000HUF/month gross
- health insurance (TAJ will be revalidated by employer) to bridge the gap: private insurance for 1-2 months
- 24,000 HUF (?) procedural fee
- colour photo (jpeg format), your blue ink signature underneath OR electronically generated application form
- bank statements (savings, regular income)
- accommodation documents
- those who work (partly) abroad also have to have a Hungarian address to get a Hungarian work permit.





Temporary residence certificate

- If you leave after graduation: Plane ticket reservation and specified date of leaving Hungary are probably necessary.
- If you stay, you do NOT need to apply for a temporary RP, too.
- However, if your extension is ongoing and your RPcard expires >> • Visit the IO 1-2 days prior to expiry OR on the expiry date

If the student is **not subject to visa**, there is **no need to apply** for a temporary residence cert. (Brazilian, Mexican students!)

 The decision (=Tájékoztatás) and a temporary RP is good for TAJ extension procedures.



BUT! NOT good for leaving the country and coming back!



When and how to start?

- Ideally: 45 days prior to the expiry or before BUT
- ... later to meet the missing document requirements in time
- >>> Letter of Apology (within 45 days) = Declaration by student why you are late with the application
- Starting the extension (new issual under the new law!)
- "Extension of the residence permit" NO
- ➤ We would like to inform you that a third country national who possesses a residence permit issued before 01.01. 2024 can apply for the issuance of a new residence permit under one of the legal titles of the new aliens (③) policing law (Act XC. of 2023) based on the transitional provisions."
- "I declare that the procedure is exempt of fee." YES (for ministry scholarship holders) even if you are between study cycles!

- Issue (first application since 1st Jan 2024) vs. Extension not the first application since 1st Jan 2024







Timing – Summer 2025



- Expiry date: last work day! (31 August, 2025 Sunday! ↔)
- EH-start: at least 2 days before biometric data recording (SUBMIT BUTTON!)
- Biometric data recording: 15 DAYS (not working days!!!) > this is the start of your case >> 15 days prior to the expiry date; Go automatically!
- Within 45 days all missing documents are to submitted otherwise your case is cancelled!
- Suggested EH-start for study purpose
 - exp. 30 June: last week in June, 2025 >> I'll contact the IO in your cases!
 - $\circ\,$ exp. 31 July: mid July, 2025
 - o exp. 31 August: end of July/first week of Aug 2025
- Purpose document attached is needed to make 'SUBMIT' button active!
- Suggested biometric data recording: 2 days after EH-start.

MATE appointments: soon published

Necessary documents

- Student Status Certificate (by your Registrar's Officer/Erasmus coordinator at MATE)
- Credit transcript (by your Registrar's Officer/Erasmus coordinator at MATE)
- Full copy of passport
- E-certificate of accommodation / old address card (in case there is no change) by the dorm coordinator or by the owner of the flat you rent AND
 - IF from MATE dormitory: a **reservation confirmation**
 - IF from a rented flat: your lease contract
 - **Notification of Accommodation** generated by the system, signed by the landlord/coordinator and YOU
- <u>Application form</u> ("Application for Residence Permit") ONLINE
- **<u>Appendix 9.13</u>** (for pursuit of studies or student mobility!)
- If you start the procedure within 1 month: Letter of Apology

For self-sponsored students also:

- a **bank account statement** (proving that you have enough money to live on)
- health insurance

If you extended your scholarship: Letter of Extension issued by Tempus Public Fund

If you graduated from MATE but pursue your studies as PhD:

- Letter of Acceptance from MATE
- Letter of Award from Tempus

Template(s) for Letter of Apology

Aim

- to give reasons why you are late with the application
- to request for an extended deadline for their missing documents' request >> give your reasons (facts, dates, names of documents properly named)

How it looks?

- formal style
- include all data (personal, educational scholarship / company and your case number(s)



Address change



- Not a separate procedure but PART of the extension case!
- Info: Current students >> Practical matters >> Residence permit >> Address change procedure

- Those with OLD address new Reservation confirmation / Lease contract with new dates + old address certificate + new "Notification of Accommodation" document (signed)
- Those with NEW address new Reservation confirmation / Lease contract with new dates + new "Notification of Accommodation" document (signed)



TAJ extension!



- Possible with the decision / temporary residence certificate / new residence permit
- Student status cert.: not older than 30 days!
- Passport
- Address certificate
- Application form
- If it is Judit (actually, in most cases, it is Judit even if you start it in Teve utca, Budapest) > authorization









- New passport? When you submit your Letter of Apology, explain that your early start was hindered by the fact that you needed to travel home for your new passport and you were waiting for necessary documents and that you can meet the expected deadlines for missing documents within the procedural time.
- In case you **travel during summer holidays**: it is possible to come back BEFORE the expiry date AND start the procedure here. It is adviseable to postpone your longer travel home!
- Experience: you have to upload a currently available stud. status cert. to be able to SUBMIT your documents and start your application online.







• How much should be the savings?

Try to be realistic and add up costs of living (accommodation, food) and insurance costs /month. Multiply it by 5-6. OR in case you have some regular income /sponsor from home (their bank statements)

 Ms.Judit's role: Should any support documents (like a student status certificate) from the academic coordinator? Or will every supportive docs be collected from Ms. Judit?

It is your responsibility to collect education-related docs from your ed. coord. Judit is responsible for institutional communication on students' behalf **as a group** towards Imm. Off.

 Coordinator's support letter is for winning time only and it is not a substitute for your active student status certificate!
